THEME: *Amazing Skies* (the principal focus must be the sky) Turn your camera lens skyward for submissions this year. Whether your skies are clear or cloudy, blue or rainbow colored, filled with a sunrise or sunset, we want to see them! We are looking for photos with a focus on the sky. Wow us. Be bold, be creative!

PHOTO CONTEST INFORMATION AND RULES

Please read carefully!

The Snap It! Summer Photo Contest (*“Contest”*) is sponsored and administered by the Union County Community Arts Council (*“Sponsor”*).

DESCRIPTION: The Snap It! Summer Photo Contest is a photography contest that encourages residents of Union County, NC, 18 years of age & older, to share their original photographs.

THEME: *Amazing Skies* (the principal focus must be the sky) whether your skies are clear or cloudy, blue or rainbow colored, filled with sunrise or sunset, we want to see them! We are looking for skies that wow us. Be bold, be creative!

FORMER WINNERS: Former winners are ineligible to enter.

ENTRY DEADLINES: The contest entry period begins at 10:00 am July 1, 2020 and ends at 10:00 am July 15, 2020. During the contest entry period, entrants may submit up to five (5) photos. Submitted photos will be reviewed prior to being accepted into the contest.

VOTING: The contest voting period begins at 10:00 am on July 16, 2020 and ends at 10:00 am July 31, 2020.

By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules.

HOW TO ENTER: Entries are limited to five (5) per individual; each entry posted must be substantially different. A Facebook account is required to enter.

WHO IS ELIGIBLE: Contest is only open to legal residents of Union County, North Carolina, who are 18 years of age and older. The winner will be required to present in person a current North Carolina photo ID to receive the cash prize. The Contest is not open to employees, board

members, their immediate families and anyone living with any employee of the Sponsor or its board members. **(Immediate family members include parents, spouse, children, siblings, grandparents, grandchildren, in-laws and domestic partners).**

ENTRY REQUIREMENTS: The sky should be the principal focus of the photo. Photo submissions with professional logos or watermarks will not be considered. Photographers should demonstrate a keen eye, and submit images that have impact, originality and creativity.

Entrants may make reasonable use of digital darkroom type techniques that enhance quality but do not distort the photograph. Only minor burning, dodging and/or color correction is acceptable, as is cropping.

Entries must be the original work of the entrant, may not have been previously published, and must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity. Sponsor reserves the right to request proof of these permissions in a form acceptable to Sponsor from any entrant at any time. Failure to provide such proof may, if requested, render entry null and void. **By submitting an entry the entrant warrants and represents that he/she and the person or third-party that appears in or is identifiable in the entry consent to the submission and use of the entry in the Contest and to its use as otherwise set forth herein.**

CONTENT RESTRICTIONS: Entries may not contain, as determined by the Sponsor, in its sole discretion, any content that:

- is sexually explicit or suggestive; violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message, contain material that is unlawful, in violation of or contrary to the laws or regulations in the jurisdiction where submission is created
- depicts animal cruelty
- is obscene or offensive; endorses any form of hate or hate group
- defames, misrepresents or contains disparaging remarks about other people or companies.

IMAGE TITLE

Each image must have a unique one to two word title. Words such as “Untitled” and “No Title” are not acceptable as part or all of an image’s title, nor are camera capture filenames or titles consisting of only numbers. Please use only English alphabet and numeric (a-z A-Z 0-9).

OWNERSHIP/USE RIGHTS: Entrants retain the copyright to their photographs. However, by entering the Contest, you hereby grant the Sponsor and its advertising and promotional agencies a worldwide, irrevocable, perpetual, non-exclusive, royalty-free, sub-licensable and transferable license to print, share through social media, publish, use, reproduce, distribute, modify, adapt and prepare derivative works of your Contest entry, and display your full name

and photograph in connection with your Contest entry, in any media formats and through any media channels.

By submitting an entry, entrant hereby grants permission for the entry to be posted on www.unionarts.org or on the Sponsors media channels and used in press materials.

VOTING: All eligible entries received throughout the contest entry period will be judged by public vote. Individuals will be able to view the approved submissions and vote for their favorite by following the specified instructions. The one (1) entry with the highest total number of votes at the end of the voting period will be deemed the prize winner, subject to verification of eligibility and compliance with these official rules. In the event of a tie, a “tie-breaking” judge will identify the prize winner.

VOTING CONDITIONS: Entrants are prohibited from obtaining votes by any fraudulent or inappropriate means, including, without limitation, offering prizes or other inducements to members of the public and/or using any websites or online forums designed to induce individuals or provide other incentives to vote for their finalist submission, as determined by Sponsor in its sole discretion. All votes are subject to final verification by Sponsor. Use of script, macro or other automated system to vote or with the intent to impair the integrity of the voting process is prohibited and all such votes will be void.

WINNER NOTIFICATION: Sponsor’s decisions are final and binding on all matters relating to this Contest. Potential winner will be notified on or before Wednesday, August 5, by direct message or comment on the applicable entry photo and will be asked to respond and provide in person their full name, telephone number (including area code), date of birth, mail and/or email address, as well as a valid North Carolina picture ID.
