

UNION COUNTY COMMUNITY ARTS COUNCIL EXHIBITION AGREEMENT

DATE: 3/30/25

BETWEEN: Union County Community Arts Council (UCCAC) and

ARTIST:

It is agreed that UCCAC will exhibit the Artist's work on a consigned basis at:

Exhibit Space Name: Union County Community Arts Council Exhibit Location: 327 S. Hayne Street, Monroe, NC 28112

Exhibit Dates: March 27 – April 24, 2025

It is agreed the work(s) will be exhibited under the following conditions:

- 1. The works consigned for exhibition and sale by UCCAC, as agent for the artist, are listed, described, and priced at retail as decided upon by the artist. These works are warranted by the artist to be his/her/their own original creations and those for sale to be the unencumbered property of the artist. All works shall remain the property of the artist unless and until they are purchased by collectors or UCCAC.
- 2. UCCAC will pay the artist seventy percent (70%) of the retail sales prices on any works sold, keeping as commission thirty percent (30%) of the retail sales price. Notice of all sales, including the name and address of purchaser and payment of all monies due, will be made not more than thirty (30) days after the close of the exhibit unless other arrangements are agreed upon by the artist and UCCAC.
- 3. The artist reserves all rights to the reproduction of works in any manner. However, the artist will not withhold permission for reproduction of works for promotional purposes.
- 4. UCCAC will be the sole party responsible for all aspects of display and placement of the consigned works within the Exhibit Space.
- 5. No sold works will be removed from the UCCAC Gallery during the exhibition dates except by mutual agreement of the artist and UCCAC. During the exhibition dates, the artist may not enter into private negotiations or sale of any art designated for the exhibition, nor may any prices be changed during the exhibition.

- 6. The artist assumes responsibility for framing and wiring and /or preparation necessary to have two-dimensional works ready to hang. Three-dimensional works and other exceptions are possible with prior approval and space permitting.
- 7. The artist agrees to pack, transport, and provide for the delivery and return of his/her/their artwork at his/her/their own risk and expense.
- 8. Insurance: The artist shall be solely and exclusively responsible for insuring properly and adequately their work and property. UCCAC has a certificate of insurance at 327 S. Hayne Street, Monroe, NC 28112. UCCAC keeps the artist's work safe and in the same condition as it was mounted in while under the roof of UCCAC. Should damage and/or loss be incurred, the parties have the right to discuss and come to agreements on damages.
